



## NEWSLETTER SUBSCRIPTION POLICY

In order to benefit from the advantages of subscribing to our newsletter, we invite you to fill your e-mail address in the box at the bottom of our page. Entering the e-mail address in the specific form and clicking on the "GO" button is equivalent to reading and understanding this document, as well as giving free consent to the processing of the e-mail address for direct marketing purposes, the Controller sending such communications only to persons who have opted in.

In order to ensure that the transmission of commercial and marketing messages is carried out in compliance with data protection rules, and to ensure additional protection of the data thus processed, the Controller has implemented the following way of subscribing to the newsletter: fill in the form for the e-mail address and confirm the subscription by clicking the "GO" button. Subscribing to our newsletter involves the processing, as personal data, of the e-mail address, respectively of the first and last name, if they result (indirectly) from the e-mail address (such as name.surname@x.com).

All data processing carried out for the purpose of transmitting information specific to the Controller's marketing activity complies with the rules described in the Privacy Policy of our Website.

Subscription to the newsletter is not conditional on payment of a fee for this purpose, so that receiving commercial and marketing messages from the Controller is free of charge. The content of commercial, marketing and informative communications will be sent to the e-mail address provided for this purpose by the user, provided that it is correctly entered. The Controller assumes no responsibility for the accuracy of the information provided by users (e.g. e-mail address).

Withdrawal of consent to receive commercial messages from the Data Controller does not affect the processing of the e-mail address for direct marketing purposes for as long as consent for this processing purpose has been validly given.
